Be one of 30 craft exhibitors as we present the Harbor Sounds Music and Craft Festival. This is a partnership with the Safety Harbor Chamber of Commerce, the City of Safety Harbor and the GFWC North Pinellas Woman's Club, Inc. The Harbor Sounds Music Festival will also feature live music and food. We expect 8,000 to 10,000 people. The event is free to the public. Since the festival continues into the evening hours, electricity will be provided to illuminate your booth. The waterfront setting is adjacent to the world famous Safety Harbor Spa in historic Safety Harbor, located in Pinellas County near Clearwater.

FEE **Non-refundable and non-transferable entry fee**
\$125 for a single booth for 2 days

1. ENTRY/DEADLINES

- Send a fully completed application and a \$125 non-refundable, non-transferable entry fee (make check or money order payable to: GFWC NPWC)
- Checks will not be cashed until September 4, 2010
- There will be a \$25 service charge for any returned checks
- Application with fee MUST be postmarked no later than September 1st, 2010

2. PHOTOGRAPHS

- Send photos representative of the work you plan to exhibit and sell at the show.
- Photos will be returned IF self-addressed envelope is of sufficient size and has appropriate postage
- If you have participated in a show with us before, pictures are not necessary.

3. BOOTH SPACE

- Booth size is 12' X 12' on asphalt
- Exhibitors must provide own set-up hardware.
- Electricity (One 20 amp 110 volt outlet) will be available. Vendors must supply 50 ft to 100 ft electric cords for their use.
- NO STAKING in the ground of any kind.

4. SECURITY

- Overnight security will be provided in the show area.

5. VEHICLES/PARKING

- NO trailers or vehicles are permitted on show grounds during the show.
- There will be free vendor parking available

6. COMMITMENT TO SHOW/SALES TAX

- Each exhibitor is responsible for collecting Florida State Sales Tax and reporting to the Florida Department of Revenue.
- Out of state exhibitors must adhere to their individual state laws.

7. INFORMATION TENT

- The information tent will be open where you may bring any emergencies, concerns or receive information about future shows and membership in the GFWC North Pinellas Woman's Club, Inc.

The GFWC North Pinellas Woman's Club, Inc. reserves the right, at its sole discretion, to require an exhibitor to withdraw from the show. In such event, the GFWC North Pinellas Woman's Club, Inc. will refund any monies paid directly to it by said exhibitor. Exhibitor shall have no recourse nor shall the GFWC North Pinellas Woman's Club, Inc. be liable in any way for any indirect, direct, consequential, lost profits or any other damages that may be claimed by exhibitor.
